Yellow Ribbon Program Eligibility (For University of Utah)

In order to qualify for the Yellow Ribbon Program at the University of Utah, you need to be eligible for the Post 9/11 GI Bill (Chapter 33) at the 100% rate and meet all of the following criteria:

Be a non-resident of Utah and be charged non-resident tuition by the University of Utah

Be pursuing a fully online degree

Will be living outside of Utah while pursuing your degree. Not living in Utah.

If you are being charged in-state tuition, then you DO NOT qualify for Yellow Ribbon. Yellow Ribbon only pays the non-resident portion of tuition.

If you will be living in Utah while you attend classes at the University of Utah and are being charged out of state tuition, then you qualify for the in-state tuition reclassification through the residency office and DO NOT qualify for Yellow Ribbon. See below about reclassification.

If you are being charged non-resident and will be living in Utah while you pursue your degree and are going to be using Post 9/11 GI Bill, then you need to apply for the in-state tuition reclassification through the residency office. Because you qualify to get reclassified, you cannot qualify for Yellow Ribbon. Therefore, you will need to fill out the “**application for in-state tuition based on military service exceptions**” found on the residency office website: <https://admissions.utah.edu/apply/residency/>

You will need to complete the application and provide the residency office with a copy of your certificate of eligibility for Post 9/11 GI Bill and evidence of intent to reside in Utah (Rental/Dorm agreement, Utah voter registration card, etc.; Full list of accepted items are found on the application. You only need to provide one). You have until the last day of the term you are applying for to complete the residency reclassification, otherwise you will be responsible for the non-resident tuition.

If you meet all of the requirements listed above to be eligible for Yellow Ribbon, then please submit the Yellow Ribbon Program request form to our office with a copy of your certificate of eligibility. It will only be granted if we have your COE AND you meet all of the requirements above.
